

**MOUNTAINS 2 BEACH MARATHON,
MOUNTAIN 2 BEACH HALF MARATHON, 10K AND BEACHFRONT 5K
RELEASE OF LIABILITY AND ASSUMPTION OF RISK**

I, _____, for myself or _____ a minor child under the age of 18 ("Participant") agree as follows:

1. I fully and completely understand that the my participation, or my minor child's participation, in the Mountains 2 Beach Marathon, Mountains 2 Beach Half Marathon, 10k or Beachfront 5K (the "Event") that is being put on by Fast Green Racing, Inc., is completely voluntarily and is inherently dangerous and involves risk of life and limb.

2. I hereby certify that Participant has trained for the Event, and that Participant is physically able to perform the strenuous tasks required in the Event. I further certify that Participant does not have any known mental or physical sicknesses or impairments, which could be aggravated by Participant's participation in the Event, including but not limited to: heart disease, high blood pressure, epilepsy, black-outs, impaired limb function, alcohol or drug abuse, psychiatric illness, and diabetes.

3. I agree in the event of any physical injury suffered while Participant is participating in the Event, that Participant will not seek recovery for medical expenses or disability from FAST GREEN RACING, INC., its officers, directors, shareholders, employees, agents, representatives, vendors, or sponsors involved with the Event.

4. Participant agrees to abide by all of the rules and regulations established by FAST GREEN RACING, INC. for all individuals who will be participating in the Event, which are in place for the health, safety and welfare of all participants of the Event.

5. Participant hereby grants to FAST GREEN RACING, INC. the right to use, publish, copy, print, and copyright, any or all photographs, video, and audio clips taken of Participant during the Event.

6. FAST GREEN RACING, INC. is not responsible for articles of clothing, personal athletic equipment and belongings of any participant in the Event which may be lost, destroyed or damaged by fire, theft, or any other causes.

FAST GREEN RACING, INC. reserves the right to dismiss any participant in the Event who: (1) does not follow the rules and regulations established by FAST GREEN RACING, INC., (2) exhibits disruptive conduct or behavior, (3) is under the influence of alcohol and/or drugs, or (4) is under the influence of, or in possession of illegal drugs.

PARTICIPANT UNDERSTANDS AND ACKNOWLEDGES: (A) THAT RISKS AND DANGERS EXIST WITH MY PARTICIPATING OR MY MINOR CHILD PARTICIPATING IN THE EVENT; (B) THAT PARTICIPATION OF PARTICIPANT IN THE EVENT MAY RESULT IN INJURY, ILLNESS, DEATH, OR DAMAGE TO PERSONAL PROPERTY; AND (C) THAT THESE RISKS AND DAMAGES MAY BE CAUSED BY OTHER

PARTICIPANTS, BY ACCIDENTS, BY FORCES OF NATURE, OR OTHER CAUSES. I, FOR PARTICIPANT, ACKNOWLEDGE AND STATE THAT PARTICIPANT ACCEPTS AND ASSUMES THESE RISKS AND DANGERS AND ASSUMES FULL RESPONSIBILITY FOR PARTICIPANT'S SAFETY AND WELL BEING WHILE PARTICIPANT IS PARTICIPATING IN THE EVENT.
